

# 2024 Nebraska FFA Living to Serve Display Handbook

## Overview

This year, Nebraska FFA Association will be highlighting the importance of **service** with the addition of the **Living to Serve Area** on the 5<sup>th</sup> floor concourse of Pinnacle Bank Arena. The **Nebraska Remembering Our Fallen** exhibit will be on display for FFA members, advisors, and guests to visit. In addition, we are adding the **Nebraska FFA Living to Serve Displays**.

This area will allow up to 20 Nebraska FFA members to create a display to explain and highlight a service project that has been completed by those individuals in their schools, communities, or regions. This might be an extension of a Washington Leadership Conference Living to Serve Plan, or it could be something an individual created on their own. It should showcase the project or event and include results and impact.

The displays will not be judged/evaluated – this is a showcase event to highlight the impact of Nebraska FFA members and their service throughout the state.

## Set-Up and Take Down

Set up for all registered displays will be on Wednesday from 10 am to Noon. Displays must be finished by Noon. Display locations will be provided to chapter advisors and members prior to convention. No switching of locations will be allowed. Displays will remain in place until Friday at 3:00 pm. All displays must be completely removed 30 minutes after the final session. Anything left on tables after the close of the final session will be thrown away.

## Display Guidelines

All Living to Serve displays will adhere to the following guidelines:

- Each student display will be provided space on one standard 8-foot table. Displays must stay within their allotted area.
- Tape, tacks, or other harmful items **may not** be used to secure items to tables or

walls.

- Displays must be *free-standing* **AND** placed on top of the table provided; nothing shall be placed on the floor as part of your display.
- Displays may include any combination of the following: free-standing display board (standard trifold, etc.); any physical items that explain or tell the story of the project (that will set on the table); pictures/graphics; any other supplemental materials that fall within the guidelines listed in this handbook.
- Tables will remain where they are set up and will not be moved.
- Live animals are strictly prohibited - displays with live animals will be required to disassemble the display.
- There will be **no** electricity available for these displays.
- FFA members are **NOT** required to be at their displays but are welcome to be there to answer questions and interact with visitors at any time.
- The displays will not be judged/evaluated – this is a showcase only!

Displays should feature information highlighting the FFA member's service project.

Information should be displayed in a creative, clean, and professional manner. Selling of any item(s) from your display is prohibited.

FFA members must sign up for a Living to Serve display space by March 1st. The link to register is at [neaged.org](https://neaged.org) on the Applications page. There are 20 spots available. Be sure to sign up early!
